LAILA AL-SHAMMA NAMED GLSEN'S STUDENT ADVOCATE OF THE YEAR

GLSEN, the Gay, Lesbian & Straight Education Network named Laila Al-Shamma of Carlsbad as the 2013 GLSEN Student Advocate of the Year. It's exciting for PFLAG that Laila's family are PFLAG members. She was honored alongside leading global, award-winning entertainment company Lionsgate; Emmy/Golden award-winning Globe producer Linda Bloodworth Thomason; and Emmv/Golden Globe award-winning actor Jim Parsons and partner Todd Spiewak at GLSEN's ninth annual Respect Awards.

GLSEN's Student Advocate of the Year honors an outstanding young person whose efforts have helped ensure a safe learning environment for all students -- and have served as a voice of change in their school and community.

UTAH MARRIAGE INEQUALITY IN A NUTSHELL

U.S. District Judge Robert Shelby struck down Utah's same-sex marriage ban in a December 20, 2013, 53 page ruling saying that, "current laws deny its gay and lesbian citizens their fundamental right to marry and, in so doing, demean the dignity of these same-sex couples for no rational reason. Accordingly, the court finds that these laws are unconstitutional." Instant, presto, same-sex marriages could be performed immediately. As unhappy as the Governor and other lawmakers were, the State of Utah had no choice but to comply (and they did), but wasted no time in asking the U.S. Supreme Court to issue a stay (a halt) so that no more same-sex marriages could be performed. The stay was issued on January 6, 2014.

Here's the kicker, the office of Utah Governor Gary Herbert said samesex couples who were married after the state's ban on gay marriage was Laila became active in the Gay-Straight Alliance (GSA) at La Costa Canyon High School when she was a freshman. She quickly became a part of the student club's leadership resulting in her successful coordination of GLSEN's Day of Silence and Transgender Day of Remembrance.

With help from her GSA, Laila later went on to spearhead a Safe Space Campaign designed to engage school personnel about the importance of safe spaces for LGBT students at school. Educators were offered a packet of information and asked to display a Safe Space sticker in their classroom. Laila will soon begin making presentations about the campaign to both middle schools in her school district. In addition, she created two public education campaigns about LGBT issues for her high

Cabinet members were told that since same-sex marriages are not recognized as legal, no one in the state can recognize them as legally married even though they were legally married with directives from the governor's office to perform the marriages. Their view (and one must question the legality of their stance), is such that the couples may not avail themselves to laws that would pertain to married couples. This would be like saying all same-sex couples who were legally married in California between the State Supreme Court's decision to allow same-sex marriage and the victory of Yes on Proposition in 2008 aren't married anymore. Legal is legal; you can't undo legal. Just like the wait for the Supreme Court to
