THE COAL MINER'S DAUGHTER



Congratulations to San Diego's (and the LGBT community's) Toni Atkins, the newly elected Assembly Speaker of the California State Assembly. Toni represents

the 78th Assembly District which encompasses the county's coastal area. Toni currently serves as the Majority Leader of the State Assembly.

Toni grew up in rural southwestern Virginia where her father was a lead and coal miner. Her mother also worked. There was no running water and her mother cooked on a wood stove – out of necessity.

Fast forward to the mid-80's when Toni moved to San Diego where she joined the staff of Womancare Health Center as Director of Clinic Services. Some

time later, she worked on Christine Kehoe's election campaign for City Council member. When Christine was elected, Toni then worked as her council representative and policy analyst. When Kehoe was elected to the state legislature, Atkins was elected to Kehoe's City Council seat and served from 2000-2008. When Mayor Dick Murphy resigned in 2005, she became the acting Mayor. Toni was elected to the State Assembly in 2010 and became Majority Leader in 2012. You are now current.

Things you may not know! Toni is the first Assembly speaker from San Diego and the first openly gay woman in the post; she is married to Jennifer LeSar and has two dogs, Haley and Joey; she played a key role in Mayor Sanders' reversing his decision about endorsing same-sex marriage. Mayor Sanders said, "She's the one who persuaded me that it was the right thing to do."

LAST BUT NOT LEAST

For the second year in a row, the **Richard P. Geysler Memorial Ethics Scholarship to Benefit LGBT Students at the San Diego Human Dignity Foundation** was awarded to **Gibran Guido**. This scholarship was established through a bequest by Philip Flick. It was to honor his partner of 44 plus years and his commitment to ethics. Richard Geysler, who



passed away in 2004, was the San Diego Human Dignity Foundation's first board president and a founding member.

Gibran is currently a Ph.D. student in Literature at the University of California, San Diego. He has written and presented six conference papers on Latino male homosexuality, identity, and HIV/AIDS. Gibran was a guest speaker at three San Diego State University courses, as well as at the University of Las Vegas. Actually, his list of accomplishments are too lengthy for this article; feel free to use Google to check out his amazing accomplishments.

Here is Gibran's essay:

"I am the co-editor to the forthcoming publication of *Queer in Aztlán: Chicano Male Recollections of Consciousness and Coming Out*. The inspiration for this book stems from a commitment to a more expansive Chicana/o social justice and liberation ethos, one which envisions the Chicano/Mexicano male queer as citizen subject and human rights holder in a diversity of local communities, cultures, and society in the US. By exploring issues of

queer youth identity, sexuality, and masculinity, as well as the force of homophobia, sexism and violence in Mexican and American culture, the book presents a more complex view of queer Chicanos/Mexicanos and contests dominant sexual norms, which threaten and have in the past ended innocent lives. The book also challenges the current scholarship of Chicana and Chicano studies to expand its conceptualization of the discipline beyond the traditional confines of male sexuality and take the contributions of queer Chicanos/Mexicanos to heart.

The collection is comprised of 33 original biographical narratives, essays, poetry, and political perspectives giving expression to personal and relatively youthful discoveries of sexuality and coming-out experiences by Chicano men. Most of our authors reside or were raised in the southwestern United States, or Aztlán - the metaphorical homeland of the Chicano civil rights movement, which ironically, given the spirit and ethos of a liberation movement, excluded gay men. One hope for this anthology is that it will continue a conversation regarding same-sex desire in Aztlán, which Chicana lesbian feminists began in the 1980s, and which invited and opened new possibilities for the expression of Chicano male queer sensibilities.

The selections are voiced and some framed by Chicano/Mexicano cultural identity amidst a homophobic home culture that in some accounts give rise to suicide attempts and other forms of violence (sadly, the suicides of recent events remind us of the urgent need to address this issue responsibly as

a society). For example, the entry by Michael Nava (author of the Henry Rios mysteries) tells of his attempted suicide as a pubescent boy and his eventual recovery to a family and school environment that hardly took notice. Also, a few of the authors of the anthology are HIV/AIDS positive and openly address the significance of the disease in their lives. We are, for example, privileged to have access to original work by the late Gil Cuadros (author of *City of God* who died of AIDS) that shares a profound beauty and wisdom about the human condition. Another author who has been supportive of this anthology is Rigoberto González, author of *Butterfly Boy*, and who is a contributor as well. As a whole the selections work against essentializing what it means to be queer, Chicano/Mexicano, and/or HIV/AIDS positive by providing diverse human experiences, expressions of sexuality and, for some, spiritual epiphanies expressive of new ways of being alive and staying alive. The editors of this collection also have compiled a unique Chicano/Mexicano bibliography on the topic, which is currently unavailable anywhere. This preliminary collection of print sources gives emphasis to themes on and by queer Chicano and Mexicano authors on male sexuality, homoerotic writing, literary criticism, fiction, prose, plays, performance art, HIV/AIDS, biography, and autobiography. The target audience is decidedly Latino queer youth and undergraduate audiences of Chicana/o Studies, Ethnic Studies, Queer Studies, and Women's Studies."

At the awards ceremony, Gibran treated us with a poem he wrote which is untitled. (see page 5)

IN GOOD CONSCIENCE



PFLAG San Diego, along with Call to Action – San Diego County, Dignity and the North County LGBTQ Resource Center are proud to be sponsoring the

documentary, *In Good Conscience*. Many of you were fortunate enough to see the DVD and hear Sister Jeannine Gramick speak to PFLAG in 2012. Although Sister Jeannine won't be speaking, this is a wonderful opportunity to see the documentary.

There will be two showings of the documentary: **Saturday, March 15** at the LGBT Center in Hillcrest (3909 Centre Avenue) and on **Saturday, April 12** at the Oceanside main public library, 330 North Coast Highway. The times for both are **10:00 am to noon**.

In Good Conscience tells the true story of Gramick's defiance of a Vatican edict to close down her ministry to gay and lesbian Catholics and be silent permanently about homosexuality. Her fight against this edict takes her to Rome where she attempts to confront the Vatican's chief doctrinal watchdog, Cardinal Ratzinger, who would later be Pope Benedict XVI. The documentary captures her humility, quiet determination, fortitude and humor.

WEDDING OF A LIFETIME

For San Diegans, Jesse Greika and Anthony Rollar, it was some wedding! They were one of the 33 couples married by Queen Latifah at the 2014 Grammys at the Staples Center in Los Angeles on January 26. They had been together for 10 years and were planning a wedding for April. They knew they couldn't afford a big wedding and then opportunity came knocking. Through a post on Facebook, it all slowly came to be. Before they knew it, Queen Latifah was marrying Jesse and Anthony during the Macklemore performance to "Same Love." Big congratulations.

3 OUT OF 4 IN THE UK

In early February, Scotland legalized same-sex marriage with the first weddings taking place this fall. The measure allows religious groups an "opt in" to perform same-sex marriages, which makes more sense than opting-out.

Scotland now joins England and Wales in marriage equality, where same-sex marriages will be taking place starting in March for England and Wales. The hold out is Northern Ireland. Hopefully, it's just a matter a time.

ANOTHER STEP FORWARD

A group of Mennonites in Colorado has put forward an openly gay candidate for ordained ministry. If confirmed, Theda Good would be the first openly LGBT minister ordained by the Mennonite Church.

Theda Good is on staff at the First Mennonite Church of Denver, where she was licensed as "pastor of nurture and fellowship," according to Religion News Service. Good's ordination must be approved by the Mountain States Conference of Mennonites, which is part of the Mennonite Church USA, the collective body of regional Mennonite communities.

Mennonites are a Christian denomination that trace their roots back to the Reformation in the 1500s. Belief and practices vary widely among different faith communities, but, according to the Mennonite church's website, "following Jesus in daily life is a central value, along with peacemaking." They share historical roots with the Amish, and there are an estimated one million members worldwide.

But even with our total acceptance of her sexuality, I quickly realized there was so much I didn’t know or understand. I didn’t want to hurt or burden my daughter by asking her too many questions and she was still figuring a lot out for herself. She needed my support and strength – not my questions. So I went on a mission to shorten my learning curve. PFLAG was my first phone call and the fact that a group met in North County meant I had the in-person support that was so important. I cannot begin to express how valuable PFLAG has been. Being able to sit with other

people on the same journey and share our stories, our concerns, our questions and our joys has meant the world to me. Having access to local resources made all the difference and it is for that very reason that I stay committed to, not only PFLAG, but the North County Resource Center.



I truly hope, no matter where you are on your journey, that you will spend some time with PFLAG. If you are struggling – we can help. If you are confused – we can help. ON, WISCONSIN

Same-sex couples in Wisconsin joined others throughout the country in filing a lawsuit seeking same-sex marriage, but efforts there are unique because of the penalties for marrying in another jurisdiction.

The litigation seeks not only to overturn the state’s 2006 constitutional amendment barring same-sex marriage, but also to enjoin state officials from enforcing a “marriage evasion law” prohibiting couples

— gay and straight — from going elsewhere to marry if the marriage would be prohibited in the state.

The penalties of violating the marriage evasion law in Wisconsin, which is the only state to have such a statute, include up to \$10,000 in fines and nine months in prison.

The lawsuit, *Wolf and Schumacher v. Walker*, was filed by the ACLU (American Civil Liberties Union), the

ACLU of Wisconsin and Mayer Brown LLP and is pending before the U.S. District Court for the Western District of Wisconsin. It is being filed by four same-sex couples.

Like other lawsuits filed throughout the country, the 29-page complaint filed by the groups in Wisconsin alleges the state’s ban on same-sex marriage violates equal protection and due process under the Fourteenth Amendment to the U.S. Constitution.
