PLEASED TO PRESENT...



Suhaila Devidasi is one of the recipients of the Rob Benzon Memorial Scholarships. Suhaila can attest to the success of the Sunburst Youth Housing Project, San Diego's only LGBT youth Shelter. While there, she became an activist and

an advocate for the trans community, as well as the LGB community. Suhaila organized fundraisers, donation drives and events in support of the various LGBT groups and homeless population, including the Youth Housing Project.

While experiencing some frustrations with traditional Western medicine, she did research into homeopathic and holistic treatments. She is currently a student at the Pacific College of Oriental Medicine.

"My name is Suhaila A. Devidasi, I'm a young trans activist in San Diego and have been involved in grassroots activism for years. I have striven to do all I can for those within the LGBT community, especially homeless youth. I myself have struggled with disownment and homelessness and have dedicated much of my time and energy to helping others that have been rejected by their families and communities.

This past February I organized an event for homeless youth, an LGBT Valentine's Day party. This was a designated safe space for queer identifying youth who were homeless or at risk of homelessness. At the party, the youth had access to resources regarding LGBT health and clinics, HIV and STD testing, and everyone who attended received a care package of toiletries and other essentials. I also organized for a case manager from Sunburst Youth Housing Project, (San Diego's only LGBT youth shelter) to be present and available to answer any questions and to assist any youth interested in applying for the program.

My goal was to reach this underserved and underrepresented part of our community and do as much as possible for them. Besides resources we also had music, games, prizes, a photo booth, pizza and plenty of candy! I wanted this event to be as fun as possible and to facilitate a positive space that would be both welcoming and empowering. By the end of the evening, everyone had had a wonderful time and each youth got to leave with a surprise gift basket and prizes that had been collected for them. We served about a dozen youth at the party and had the two dozen or so extra care packages donated to three different homeless youth shelters in San Diego.

The care packages, prizes and gift cards the youth left with were collected by the University Christian Church congregation, a local LGBT affirming church in Hillcrest. They also graciously donated the community space we used for the event as well. I had worked with this congregation

before and they were very excited to help me realize my plans for this project. In the past, we had collaborated to collect needed items for the youth at the Sunburst Youth Housing Project. They were very excited to help once again and contribute whatever was needed for the Valentine's Day project.

This was the biggest event I had ever organized and with all of the people and contacts involved it was quite difficult. It was most definitely worth it,however, and I am so blessed and grateful I was able to create a safe space and time for my LGBT family. I remember what it was like to experience homelessness so it was beautiful to see youth that could even for a short while forget about the difficult realities of homelessness and simply enjoy themselves.



Now and in the future, I intend to continue on with my activist endeavors and facilitate change and transformation wherever I am and in whatever way I can. I currently have plans for future

actions, events, and fundraisers all for the benefit of the LGBT community. It is my goal to change as many hearts and minds as possible.

As a current student at San Diego City College, it is my goal and intention to create a Gay Straight Alliance or LGBT club at my school. As of now, there are no safe spaces on campus and many of the staff and faculty are in need of LGBT sensitivity trainings and workshops. I have already been in contact with various case managers, organizers and fellow activists from different San Diego non-profits to ensure that we can create the changes that are needed on this campus. I have reached out to our student government and also found a teacher that supports us and will be our club sponsor. I will do all I can to create that safe space and to serve LGBT youth and allies through my school. I also plan on creating a program that caters to LGBT homeless youth and that gives them access to our school showers and resources.

As long as I live here in San Diego I will do whatever I can to help my community. For long term and future endeavors, I plan on leaving the country and working with an NGO in India. Once I have my degree in Traditional Chinese Medicine I plan on offering free medical care to those in need in Vrindavana, India. I still plan on helping the LGBT community there as well. I will open my own clinic and employ and serve those in the Hijra or third gender community. My main goal for now and the future is to help other trans people live fearless lives of integrity with dignity and respect. My motto has always been to help the helpless and to defend the defenseless. Those guiding values will help me make the world a better place."


DURING THE MONTH OF OCTOBER

MOORE NEWS

In early 2016, anti-gay Alabama's chief justice, Roy Moore, ordered his state's probate judges to deny marriage licenses to same-sex couples because he did not believe that the Supreme Court's Obergefell v. Hodges decision applied to Alabama. A few months later, he finally gave up his fight, even though he still believed the Supreme Court made an error in that Alabama's marriage ban remained legitimate. In ending his interference, he threw out all challenges to marriage equality in Alabama, while at the same time making clear his displeasure with Obergefell, calling it a "lawless act" and same-sex relationships "immoral."

For his defiance, in late September, 2016, Moore was suspended from the bench, without pay, until his term ends in 2019. It seemed Moore had big plans in mind. He resigned in April, 2017 to pursue the vacant Alabama senate seat left by Attorney General Jeff Sessions. Although he didn't win the election outright (neither candidate received more than 50 percent of the votes), there was a runoff election and Moore won. Defeating his opponent entitles him to seek the senate seat against the Democratic candidate, Doug Jones and Independent candidate, Mac McBride. The general election is December 12. Fingers crossed.

A HEARTFELT LETTER



Annette Ottone, PFLAG North County Coastal Regional Director, was one of the guest speakers at the County of San Diego Employees Resource Group's participation in National Coming Out Day. Annette read the following letter written by Olivia Ottone. She is the daughter of Annette and Remos and

the 2012 recipient of the Raytheon STEM scholarship.

"Hi, Mom,

I think you know by now, but when the 17 year old version of myself came out to you and Dad, it had absolutely nothing to do with you. It was about me. I did it for me. I needed you to know, so that I could feel comfortable in my own skin and start being honest. My coming out was selfish and unapologetic, in a way that left little room for you to explore the information I dropped at your feet. I can never understand how you felt as a parent hearing your child admit the words, 'I'm gay.' All I know is what followed.

For a few months, I watched and felt us struggle as you tried to understand what I had wrestled with for the last three or so years. However, what I am so fortunate to be able to say is that it was always clear that the difficulty was in understanding – never in accepting. And we got past it. After I came out, you sought resources when your teenager didn't want to talk about my queerness and was less than forthcoming with information about how to be an ally. You did what I wish so many parents could do. You embraced you child's truth and took it upon yourself to be the thing that makes the world a more accepting place.

While I've been in Indiana, I've admired from afar how PFLAG has been woven into our family's and our friends' lives. You tell me stories about the conversations you have with other parents and students, and I see how wholly being an ally to the queer community has become a part of your identity; and, I wonder how I get to be the one who is so lucky. When you and Dad send pictures from San Diego Pride, or you tell me about new terminology you learned, or when I see you wearing rainbow earrings, I don't feel like an 'other' because somehow you out gay me. This is ridiculously cool.

But you know this. I think, at some point, you realized that your induction into the queer community as my mother was about more than my coming out to you because you have a voice and a platform inaccessible to me. The way I see it, straight allies have the opportunity to do something no one within the community can do. You have the ability to empathize with the straight and cis friends and family members of those within the LGBTQ+ community.

More importantly, you have your straight superpower. Your voice. Your perceived credibility. When you support the community people cannot dismiss you as simply being an advocate within the community sticking up for yourself. When you are a vocal, unapologetic ally, you demonstrate the ability of a straight person to embrace a cause, without necessarily reaping the direct benefits of your support. When you proudly declare yourself a PFLAG parent and offer yourself as an example and resource to those still trying to understand, you speak up for those who feel silenced.

This is so valuable. When I came out to you and Dad, I made arrangements to sleep elsewhere, just in case things didn't go well. Thank you for not making me default to my contingency plan. Thank you for actively working to morph our heteronormative culture into one in which people who don't match the standard don't have to be fearful. Thank you for being an ally, not just to me, but to the entire queer community. I know you sometimes say you're just being a "mama bear," but you know as well as I do that this is more than that.

Thank you. I have one more thing to say – because I know you are reading this to an audience. Everyone, take a page out of my mom's book. You don't have to be perfect or well informed to be a great ally; you just have to be committed to educating yourself and supporting the queer people in your life. Use your superpower, damn it.

Mom, I love you. I cannot thank you enough for all you do.

TRANSGENDER AWARENESS WEEK & DAY OF REMEMBRANCE



From **November 14–20**, individuals and organizations around the country will participate in Transgender Awareness Week to help raise the visibility of transgender and gender non-conforming people,

and address the issues the trans community faces. The final day of Transgender Awareness Week is the Transgender Day of Remembrance, an annual observance on **November 20** that honors the memory of those whose lives were lost in acts of anti-transgender violence. People who were perceived to be transgender or who are gender variant are among those being remembered. Please join the San Diego LGBT Center in remembering these individuals at a march that begins at The Center (3909 Centre Street in Hillcrest) at 6:00 pm. A program will follow at 7:00 pm at The Center.

AND THE BEAT GOES ON...

The latest "directive" from Attorney General Sessions goes like this: "The government must do as much as possible to accommodate those who claim their religious freedoms are being violated." Never mind that it undercuts federal protections for LGBT people.

Trump pledged to his evangelical supporters that he would protect religious liberties, effectively lifting a burden from religious objectors to prove that their beliefs about marriage or other topics are sincerely held. Under the new policy, a claim of a violation of religious freedom would be enough to override many anti-discrimination protections for LGBT people, women and others. This is a signal to the rest of these agencies to rethink the protections they have put in place on sexual orientation and gender identity. The DOJ made it clear that this direction tilted the balance very far in favor of people of faith who do not want to recognize same-sex marriage. The small nugget on this is that experts on religious liberty are calling these sweeping changes a legal powder-keg that could prompt wide-ranging lawsuits against the government.

Claim Sessions, "Except in the narrowest circumstances, no one should be forced to choose between living out his or her faith and complying with the law. To the greatest extent practicable and permitted by law, religious observance and practice should be reasonably accommodated in all government activity." Not only does the administration want to give federal agencies a license to discriminate, but this lays the groundwork for legal positions that the Trump administration intends to take in future religious freedom cases, envisioning sweeping protections for faith-based beliefs and practices in private workplaces, at government jobs and even in prisons. That the government is already exacerbating the fact that more than 50 percent of Americans live in an area of the U.S. where LGBTQ people are at risk being fired, evicted, or denied services because of who they are — and two-thirds of LGBTQ people report having faced such discrimination in their lives. Now they get to make it worse.

Here is part of what this directive will do: A Social Security Administration employee could refuse to accept or process spousal or survivor benefits paperwork for a surviving samesex spouse; A federal contractor could refuse to provide services to LGBTQ people, including in emergencies, without risk of losing federal contracts; Agencies receiving federal funding, and even their individual staff members, could refuse to provide services to LGBTQ children in crisis, or to place adoptive or foster children with a same-sex couple or transgender couple simply because of who they are.

USA IS AGAINST G.A.Y.

Just when you think the "government" can't be any more anti-LGBTQ, they strike again. Remember when candidate Trump promised to defend LGBTQ rights?

The United Nations Human Rights Council's motion was entitled "The Question of the Death Penalty." Isn't putting "Human Rights Council" and Death Penalty together a bit of an oxymoron? The motion called for countries where the death penalty is legal to ensure it is not imposed in a manner that is "arbitrarily or in a discriminatory manner" or for forms of conduct such as apostasy, blasphemy, adultery and consensual homosexual relations.

Shamefully, the United States was one of 13 nations, including some of the most repressive nations on Earth, to vote against the resolution which condemned the death penalty. The other opposing nations were Saudi Arabia, Iraq, Qatar, Japan, the United Arab Emirates, Bangladesh, China, India, Egypt, Ethiopia, Qatar, Botswana, and Burundi. There were 27 countries for the motion and seven abstentions.

The excuses for the vote were not only lame, some of them were untruth that were put out by the UN Ambassador, Nikki Haley.

Director of HRC Global, Ty Cobb, put out this statement, "Ambassador Haley has failed the LGBTQ community by not standing up against the barbaric use of the death penalty to punish individuals in same-sex relationships. While the U.N. Human Rights Council took this crucially important step, the Trump/Pence administration failed to show leadership on the world stage by not championing this critical measure. This administration's blatant disregard for human rights and LGBTQ lives around the world is beyond disgraceful."

MORE SHENANIGANS

Attorney General Jeff Sessions has formally determined that a 1964 federal civil rights law does not protect transgender workers from employment discrimination. The basis for this argument is, "Title VII's prohibition on sex discrimination encompasses discrimination between men and women but does not encompass discrimination based on gender identity per se, including transgender status." While he says this is not a policy, but a conclusion of the law, he said the DOJ will take this new position in all pending and future matters. Anti-LGBT employers could basically put a 'Transgender Need Not Apply' sign in their window.

Sessions stance is the opposite of reality. The National Center for Transgender Equality put out, a statement saying "Courts have repeatedly ruled that transgender people are protected by sex discrimination laws in employment, education, housing and healthcare. We'll see him in court."
