## MOVING RIGHT ALONG

The demise of the military's discriminatory "Don't Ask, Don't Tell" policy, which was rescinded September 20, has opened up many possibilities for gay service members, including the Pentagon's decision to allow military chaplains to marry couples in the jurisdiction where they are legal.

There are certain regulations which are possible to live with including that ceremonies must not be considered official Defense Department events. wedding ceremonies may not violate local laws, private functions held on military bases do not make it a DoD activity, and similar regulations. There was nothing outrageous.

Of course there was praise from the Human Rights Campaign, the nation's largest lesbian, gay, bisexual, and transgender civil rights organization.

#### 12TH ANNUAL ASIAN FILM FESTIVAL

The film festival takes place at the Hazard Center UltraStar Cinemas in Mission Valley from October 20-28. There are over 100 films spanning more than 20 countries.

As PFLAG San Diego does every year, we are co-sponsoring one of the LGBT evenings. The film is *I Am* and takes place on **Saturday**, **October 22 at 5:10 PM**. Here is the synopsis: Having lost the opportunity to tell her mother that she is a lesbian, a young Indian filmmaker in search of answers, travels across India to meet with parents of other gay and lesbian South Asians. *I Am* is a personal and revealing

film that journeys to a landscape where being gay was until recently a criminal and punishable offense. With courage, determination, and humor, families share untold stories that have thus far remained in the realm of secrecy and silence. It is a unique and groundbreaking film that defies the very genre of documentary filmmaking.

#### WHEN YOU THINK YOU'VE HEARD EVERYTHING

A gay couple from a small town in Tennessee allege that they were beaten as they tried to attend services at Grace Fellowship Church and that the assault was prompted by the father of one of them, who happens to be the church's pastor.

"I went over to take the keys out of the ignition and all the sudden I hear someone say 'sick'em," said Jerry Pittman Jr. who

was assaulted with his partner, Dustin Lee.

Pittman said the attack was prompted by the pastor of the church, Jerry Pittman Sr., his father.

"My uncle and two other deacons came over to the car per my dad's request. My uncle smashed me in the door as the other deacon knocked my boyfriend back so he

#### **ANOTHER LIFE LOST**

It was exactly a year ago that it was reported in the newsletter the deaths of many adolescents and teens who committed suicide due to bullying. Now we add another young soul: Jamey Rodemeyer. Taunted since grade school for hanging out with girls, 14-year-old Jamey told his parents things were finally getting better since high school started. Meanwhile, on a blog his parents didn't know about, he posted increasingly desperate notes ruminating on suicide, bullying, homophobia and pop singer Lady Gaga.

A few days later, he hanged himself outside his home in suburban Buffalo.

Tracy Rodemeyer said her son was hurt deeply by words from the time he was very young. Boys started picking on him in elementary school, she said. By middle school, the bullying was overwhelming. His friends would report the abuse, and school officials would pull the boy and the alleged bullies into the office. Rodemeyer also regularly saw a school social worker, who would call his mother after meetings.

"People would be like `faggot, fag,' and they'd taunt me in the hallways and I felt like I could never escape it," he said in a YouTube video posted in May as part of Dan Savage's "It Gets Better" project, which seeks to give voices and hope to bullied gay and lesbian teenagers. The teen's video has now been viewed more than a million times.

Rest in peace.

#### LET'S HEAR IT FOR SDSU

San Diego State University announced the approval of the state's first LGBT Studies major to start in the spring of 2012.

The LGBT Studies major at SDSU will be the first of its kind within California and the California State University system. SDSU has a rich tradition of supporting the LGBT community within its school and state network. The LGBT Studies program will focus on 27 upper division units in the major and classes will be formally announced by the university in the coming months.

The university will also expand current LGBT course offerings to include Valuing Human Diversity, LGBT Literature and Culture, and Queer Texts and Contexts.

couldn't help me, punching him in his face and his chest. The other deacon came and hit me through my car window in my back," said Pittman. He said bystanders did not offer assistance. He said the deacon yelled derogatory homosexual slurs, even after officers arrived. He said the officers never intervened to stop the deacons from yelling the slurs.

Pittman said neither he nor Lee was allowed to press charges while at the church. Shortly thereafter, they did file assault charges against Deacons Billy Sims and Eugene McCoy. Pittman pressed additional charges against his father and Deacon Patrick Flatt. Pastor Pittman's attorney contacted their local news by phone and said she had no comment and demanded news reporters not contact the pastor.

#### WHAT NEXT?

Some people don't want Ricky Martin to visit Honduras in October as part of his world tour, but it's not entirely clear if it's right-wing religious leaders or government officials objecting.

Martin is scheduled to perform in Tegucigalpa on October 16. The minister of interior of Honduras, Africo Madrid, is telling the media that evangelical and Catholic leaders want Martin's visa denied in order to "protect the moral and ethical principles of our society." Madrid says the Christian officials don't approve of Martin's homosexuality or the fact that he's a proud father to two children. "His nuclear family is not the type of family that Honduran society and laws approve of," Madrid said, according to Fox News Latino.

The odd thing is that *El Heraldo* newspaper reports that sources in the Honduran secretary of state's office claim there have been no written petitions to deny Martin entry into Honduras. Considering this as well as Madrid's statements to the media, it may be Madrid who really doesn't want Martin coming to his country.

Michael is a recent graduate of Castle Park High School and has entered his freshman year at San Francisco State with a goal of a Bachelor's in Journalism. Michael has open-minded views and attitudes on life. His maturity and trustworthiness are admired by others.

"The lack of consciousness manifested in the beliefs of the American public stands in the way of the LGBT community obtaining human rights. Specifically, the oppression of women plays a vital role in the marginalization of LGBT people due to the widely accepted notion that to act or be in any way female is degrading. Strict boundaries for each gender are deeply infiltrated in the values of American society, which inevitably affects everyone in the way that we act and even in the way that we love. Once a person breaks out of the expected gender norms, he or she is seen as a threat to the established definitions of what to be masculine or feminine is. The assumptions created due to sexism are that those in the LGBT community are deviating from their supposed roles and are therefore

bizarre freaks of nature.

The mainstream media often reinforces the stereotypical gender roles of 'machos' and 'damsels in distress' to the



extent that citizens accept such notions as commonplace and natural. Thus, when a woman is labeled as 'butch' or a man appears 'feminine,' their behavior conflicts with the already established codes of conduct set for each gender. Without any questioning, many Americans blindly accept what society and the media preaches as being true or abnormal regarding gender. Widespread approval of sexism ends up leading to the institutionalization of homophobia, which creates beliefs that cannot be easily taken down. The fact that misogvnistic values are manifested in the beliefs of the American people signifies that a lack of consciousness is to blame for ignorance and contempt towards the LGBT community.

Aiming to major in journalism, I will benefit from your scholarship in paying for expenses at San Francisco State University. Becoming a successful journalist will motivate me to use the media to further strive for the rights and equality of the LGBT community. Through my writing, I hope to spread awareness about LGBT issues and enroot consciousness into the minds of all Americans.

#### **WAL-MART ADDS TRANS PROTECTIONS FOR EMPLOYEES**

Whether you are for or against Wal-Mart for various reasons, they must be applauded for their latest pro-gay move. They have added gender identity to their list of protected categories for employees. Wal-Mart already has protections for LGB employees. The additional transgender protections were praised by the Human Rights Campaign.

"What matters in the workplace is how you do your job, not your gender identity or sexual orientation," HRC President Joe Solmonese said in a press release. "As the nation's largest private employer, Wal-Mart shows that doing the right thing is also good for business. We urge them to continue to move forward by ensuring all of their LGBT employees receive equal benefits."

#### JUST LIKE OBAMA, WE ARE EVOLVING

As bans on gay marriage and civil unions spread across the majority of America in the past decade, new U.S. Census figures reveal a starkly different trend: The number of same-sex partnerships skyrocketed even in the most prohibitive states.

Some 646,464 gay couples said they lived together in last year's census, an increase of 80 percent from 2000, according to revised figures released recently. Samesex couples make up just 1 percent of all married and unmarried couples in the U.S., but as a group they, nonetheless, made large gains in every state.

The results include the first estimate of the nation's gay married couples. More than 131,000 same-sex couples identified themselves as husbands or wives, accounting for about 1 in every 5 gay couples who live together.

But the new numbers may not represent a real increase in gay couples as much as a change in attitudes. Some demographers say the stigma of homosexuality is easing, emboldening more people to disclose their same-sex partnerships. As evidence, some of the biggest increases in gay couples occurred in unlikely places.

"I think it tells us how same-sex couples view their relationships, as apart from the legal definition. Many of them view themselves as spouses but live in states that don't recognize them in any way," says demographer Gary Gates at the UCLA Law School, which analyzes census data on gay and lesbian couples.

This gives new meaning to the statement, "Out and proud."

#### **PROPOSITION 8 SEE-SAW**

In last month's newsletter, we reported that screenplay writer Dustin Lance Black (he won the Academy Award for the *Milk* screenplay) wrote a play based on the trial to overturn Proposition 8. The main reason for doing so was to educate anyone interested in learning exactly what happened during the trial. The Prop 8 backers managed to get the U.S. Supreme Court to bar any broadcasting of the trial.

Then there was a victory which may

be short-lived. The Courage Campaign petitioned U.S. District Judge James Ware (California) to release the Prop 8 trial videotapes. And he did. By allowing the public to view this testimony, it will show that Prop 8 was based on prejudice, that ProtectMarriage.com had no credible defense and that Judge Walker was not at all biased. The fear is that groups like ProtectMarriage.com and NOM (National Organization for Marriage) will be appealing Judge Ware's decision.

## AND BRITAIN MAKES TWO

Following on the heels of the United States, who in June began issuing gender neutral passport applications and citizenship forms for children of American parents born out of the country, passport forms in the U.K. are being updated to include options for same-sex parents.

Instead of being limited to the traditional "mother" and "father" entries, the new forms are expected to include options for "parent one" and "parent two."

According to the **BBC**, agencies will also issue gender-free passports to allow transgender people to opt out of identifying themselves as specifically male or female.

According to Sam Dick, head of policy at the gay rights group Stonewall, "These changes simply reflect the realities of modern life for families — making it clearer for same-sex parents applying for passports for their children and more straightforward for the officials who process them."
